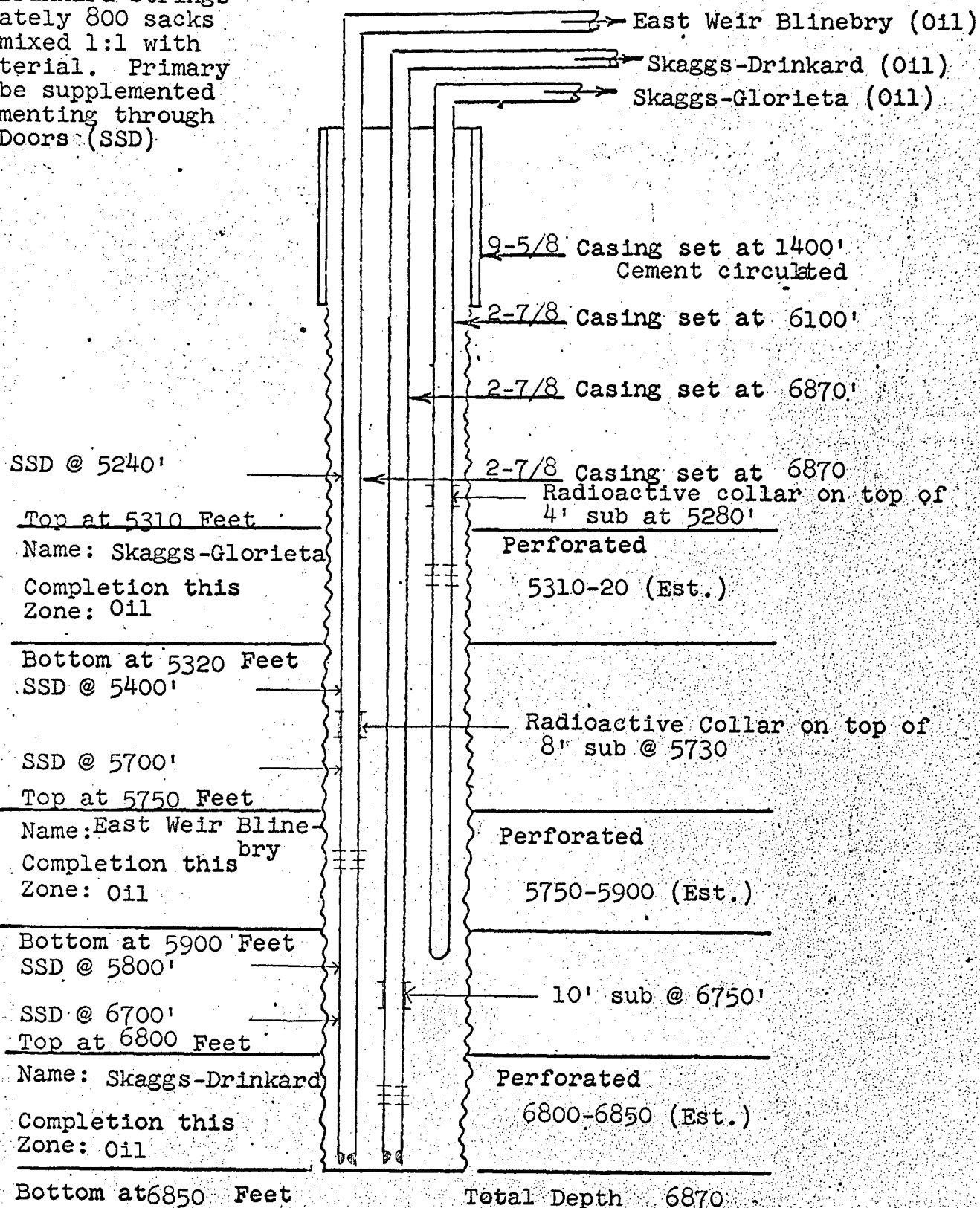

Sliding Side Doors (SSD)

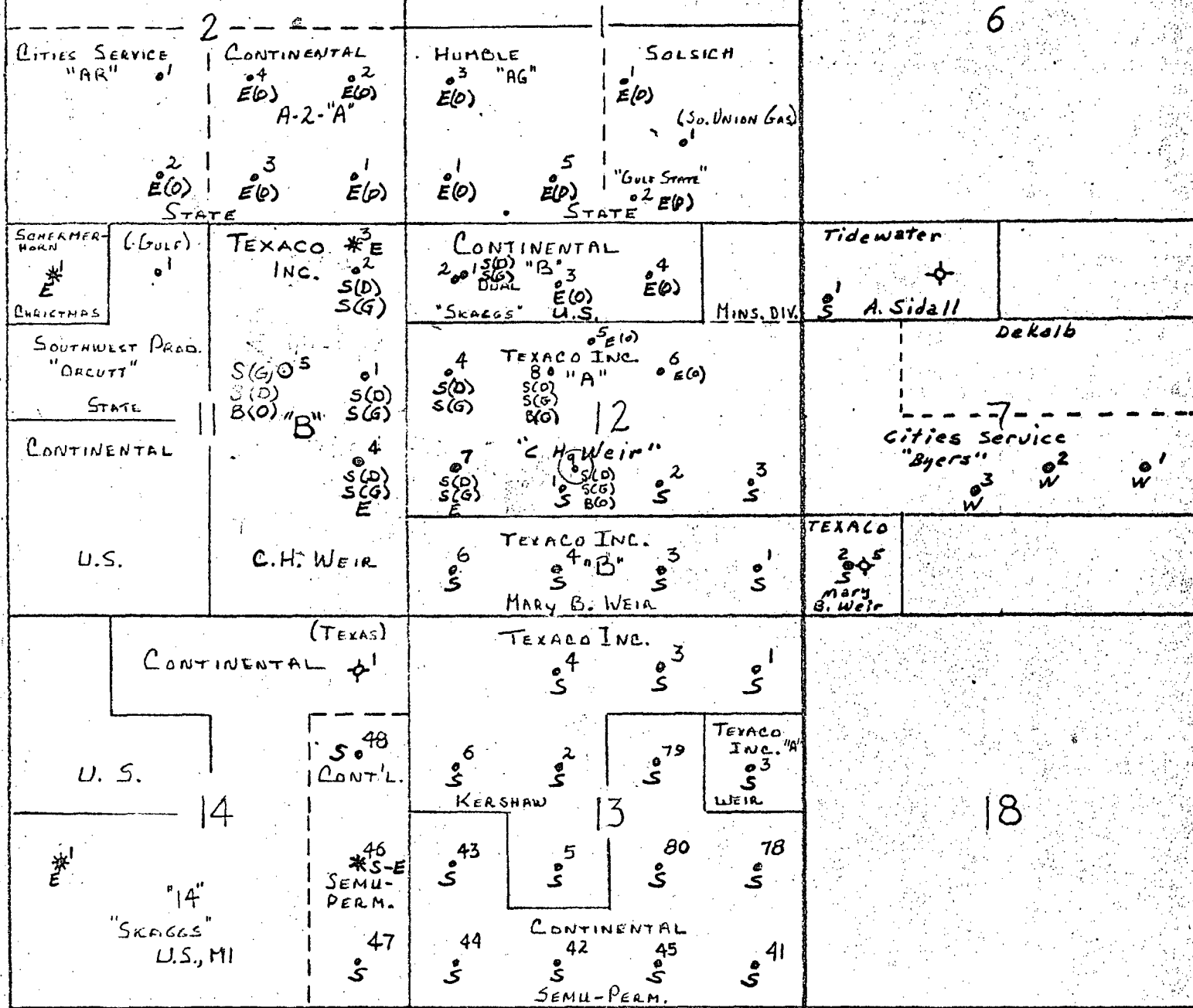
