Total Depth of well 9567'; Plug back total depth 5000'.

Well plugged and abandoned as follows:

Spotted 30 sack cement plug over San Andres perms from 4920-4924'. Shot off 7" casing at 4213' and pulled casing from well. Spotted 50 sack cement plug from 4265-4165' and spotted 10 sack cement plug at the surface. All spaces between cement plugs were filled with mud laden fluids in accordance with approved methods. A steel marker per NMOCC specifications was installed. Well plugged and abandoned February 18, 1966.
