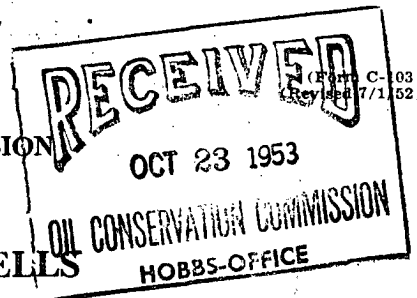

Installed Bethlehem 228D-20A Series 50 Pumping Unit w/30 HP Electric Motor. Ran 219 jts 6825.93' of tubing. Tubing set at 6854', seating nipple at 6839', perforations at 6840-43'. Ran Pump & Rods.

Pumped on Oil Conservation Commission test 95 bbls oil, 4 bbls water thru 2-3/8" tubing in 24 hrs 12 x 64" spm. Gas Volume 141,900 cu. ft. GOR 1493. Allowable before equipment replacement 91 BOPD. Allowable after 91 BOPD same as before.
