DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Acidized w/3000 gallons 15% NE acid by Cardinal Chemical Co. Injection rate 68 GPM. TP 1000-800#. Casing packer 500#. Flushed w/27 bbls oil. Packer failed to hold, reran packers. Adidized w/3000 gallons 15% NE acid by Cardinal Chemical. Injection rate 50 GPM. TP 1300-990#. CP 500#. Flushed w/27 bbls oil.

RESULTS: Swabbed 74 bbls oil 79 bbls BS & 51 bbls acid water in 12 hours. In 24 hours swabbed and flowed 219 bbls oil 61 bbls BS&W. In 11 hours swabbed and flowed 171 bbls oil and 61 bbls BS&W. Well KO and flowed 78 bbls fluid in 7 hours. Well flowed 92 bbls oil and 10 bbls BS&W in 6 hours.
