8/22/04 Start pulling out of hole w/ 9395' of 1.5" coil tubing fish.

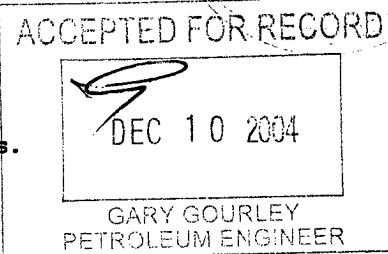
8/24/04 Finish pulling out of hole & lay down tubing.
