Strata Production Company proposes to pull 4 1/2" casing and plug back as follows:

CIBP @ 8180 w/35' of cement dumped on top
25 sx (50' in and out) of 4 1/2" casing stub est 7600'.
25 sx @ 5020 to 4920' to cover top of Yeso @ 4980.

After the well has been plugged back Strata Production Company proposes to run a 4 1/2" 11.6# J-55 liner; Top @ 2961 hanging inside 7" intermediate casing and bottom @ 4750'. The proposed liner will be cemented with enough cement to cover the top of the pay with at least 700' of cement.
