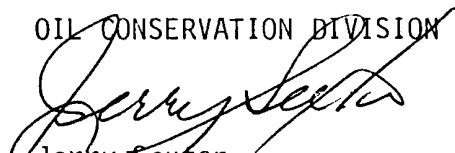
Gentlemen:
