MIRU Key Rig #7. Spud well @ 11:30 hrs 11/21/2004 (16" conductor set & cemented @ 60'). Drill from 60' to 231'. Survey @ 188' = 3/4 deg. Drill to 692'. Survey @ 649' = 1 deg. Drill to 1171'. Survey @ 1128' = 3/4 deg. Drill to 1530'. Survey @ 1511' = 1 deg. Circulate & condition hole. Run 36 jts 8 5/8" 24# J-55 casing. Rig up BJ Lines. Pumped 500 sx Class 'C' cement +2% CACL2 + 4% @ 13.5 ppg. Tail w/250 sx Class 'C' cement w/2% CACL2 mixed @ 14.8 ppg. Had 37 bbls (119 sx) cement returns to surface. Bumped plug w/1300 psi. WOC 6 hrs. Nipple up and test BOP's test pipe rams and lines to 250/1500 psi. Test casing to 1000 psi. Drill out float eqpt. to 1530'. Test to 185 psi = 12.0 ppg.
