TIH w/swedge, bumper sub, jars, drill collars and tubing. Worked swedge past tight spot in 5-1/2" casing (3144-52'). TIH w/freepoint tools. Pipe free @ 3100' and 50% free @ 3160'. TIH w/casing cutter and cut @ 3205'. Pulled casing. Swedge out 8-5/8" casing 3137-3152' and 3135-70'. Some drag 3135-42'. TIH w/lead seal patch and 75 joints 5-1/2" 17# casing. Latched onto 5-1/2" casing. Circulated hole and found hole in casing. Set composite plug @ 9100'. Tested casing. Casing is good 7681-9100'. Hole in casing 3403-7681'. Freepoint 5-1/2" casing - 85% free @ 7781'. Cut casing @ 7750' and TOH w/135 joints. TIH w/slip joint and 181 joints 5-1/2" casing. Slipped over casing stub. Cemented w/600 sx Lead cement and tailed in w/200 sx Class "C". Tested casing to 1500# for 30 min. Tested good. Drilled out composite plug @ 9100'.
