5. GIH and spot 35 sx class "C" cmt plug from 50' below and 50' above csg stub. WOC & tag.

6. Spot 35 sx (100') class "C" cmt from 560' - 460' inside 9-5/8" csg. WOC and tag.

7. Spot 18 sx class "C" cmt from 60' - 4'.

8. RD MO. Cut off WH and install P&A marker. Clean and restore location.

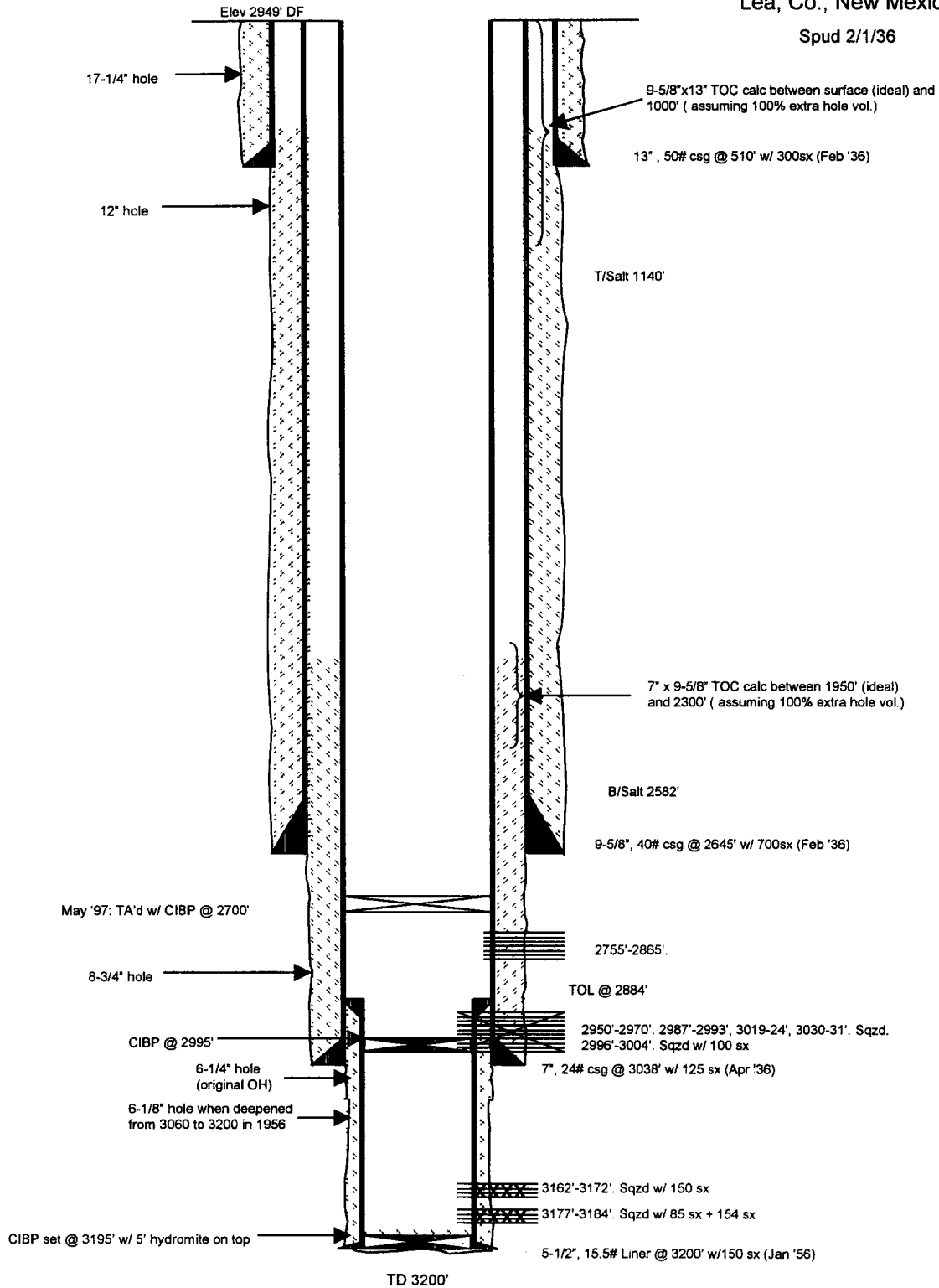

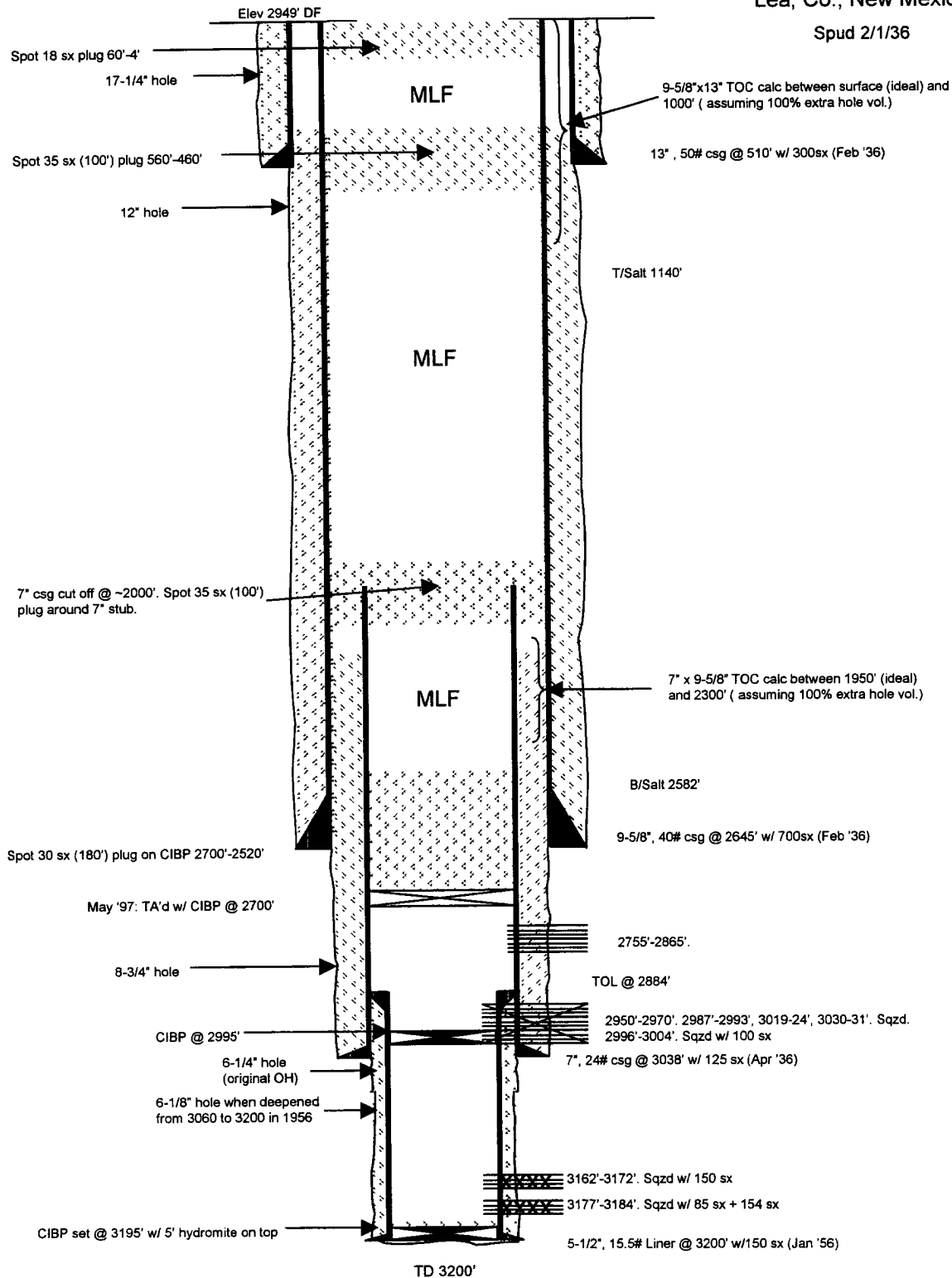
