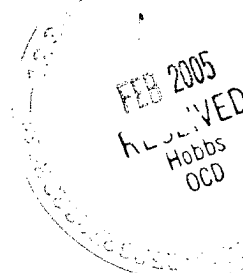

MIRU completion unit. Drill cement from 5615' to CIBP @ 5650' (do not drill CIBP). Perforate Delaware 5520-40' (20), 5560-70' (10) and 5610-20' (10). If indicated, acidize w/2000 gal 7-1/2% NEFE HCl and 50 ball sealers. If shows warrant, will frac.
