InFlow Petroleum Resources, LP took over operations of this property in February of 2004. We have not had an adequate opportunity to review the behind-pipe pay in this well and would like to request an extension of TA status for another 24 months. During the next 24 months, we will reach a determination to P&A the well or return it to production.

There is currently a CIBP @ 3290'. Perforations are from 3070' - 3260'.

We propose to set a CIBP @ 2980' (90' above the top perforation), perform an MIT test and TA the well.
