Open DVT and circulated no cmt to surface. Stage two cemented with 800 sxs Interfill C Neat at 11.9 ppg lead slurry and 50 sxs Premium Plus Neat at 14.8 ppg tail slurry. Circulated 425 sxs to Surface. BLM Patricia Hutchings was on location to witness.
