Yates Petroleum Corporation respectfully requests permission to vent approx. 5 MCFPD. Approx. 3 MCFPD is used on lease to run pumping equipment. The closest p/l is approx. 10 miles. Avg. oil per day is 6 bbls w/ an avg/est. cost for gas connect of \$900,000.. This is currently the only well on this lease and until further development it is uneconomical to run a pipeline.
