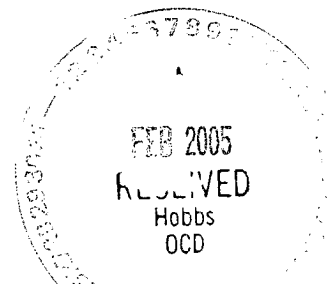

A central tank battery will be located in the SE/4 NW/4, Sec. 7 T18S R35E. Proper allocation for production will be measured with meters at the battery. Mack Energy Corporation has made notification to all parties owning an interest in these leases, including the oil purchaser, of the intent to commingle. The interests in all pools on this lease are common.
