

WOC 36.5 hrs. Cut off csg, weld on wellhead adn NU BOPE. NU BOPE and test to 1500 psi. OK. TIH and start drlg.

Drld to 4400'. RU csg crew and ran 138 jts 4-1/211.6# N80 and J55 LT&C and ST&C csg. Set @ 4400'. Smt as follows: Lead slurry: 690 sxs Halliburton Light Premium Plus. Tail slurry: 250 sxs Premium Plus. Circ 63 sxs to pit. WOC. Cut off csg, weld on wellhead and jet pits. Released rig @ 1400 hrs 3/4/05.
