On February 11, 2005, Salta lined tbg & pkr were run to 4307' RKB. When the csg was pressured, the 8 5/8" circulated indicating a csg leak. Seely Oil Company proposes the following:

1. POOH w/ Salta lined tbg & pkr.
2. GIH w/ RBP & pkr. Set RBP @ 2800' +/- Test RBP, pkr & tbg to 2000 psi.
3. Isolate csg leak. Squeeze leak. POOH w/ pkr & tbg.
4. Drill out cmt & test leak. Retrieve RBP.
5. GIH w/ Salta lined tbg & pkr to 4300' +/- RKB. Circulate pkr fluid.
6. Set pkr & test csg to 500 psi.
7. Request authority to begin injection.
