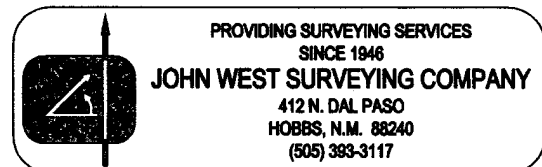

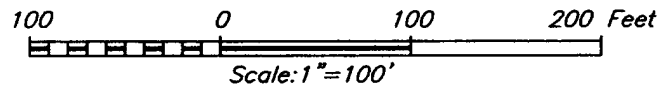

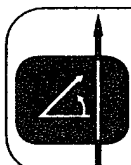

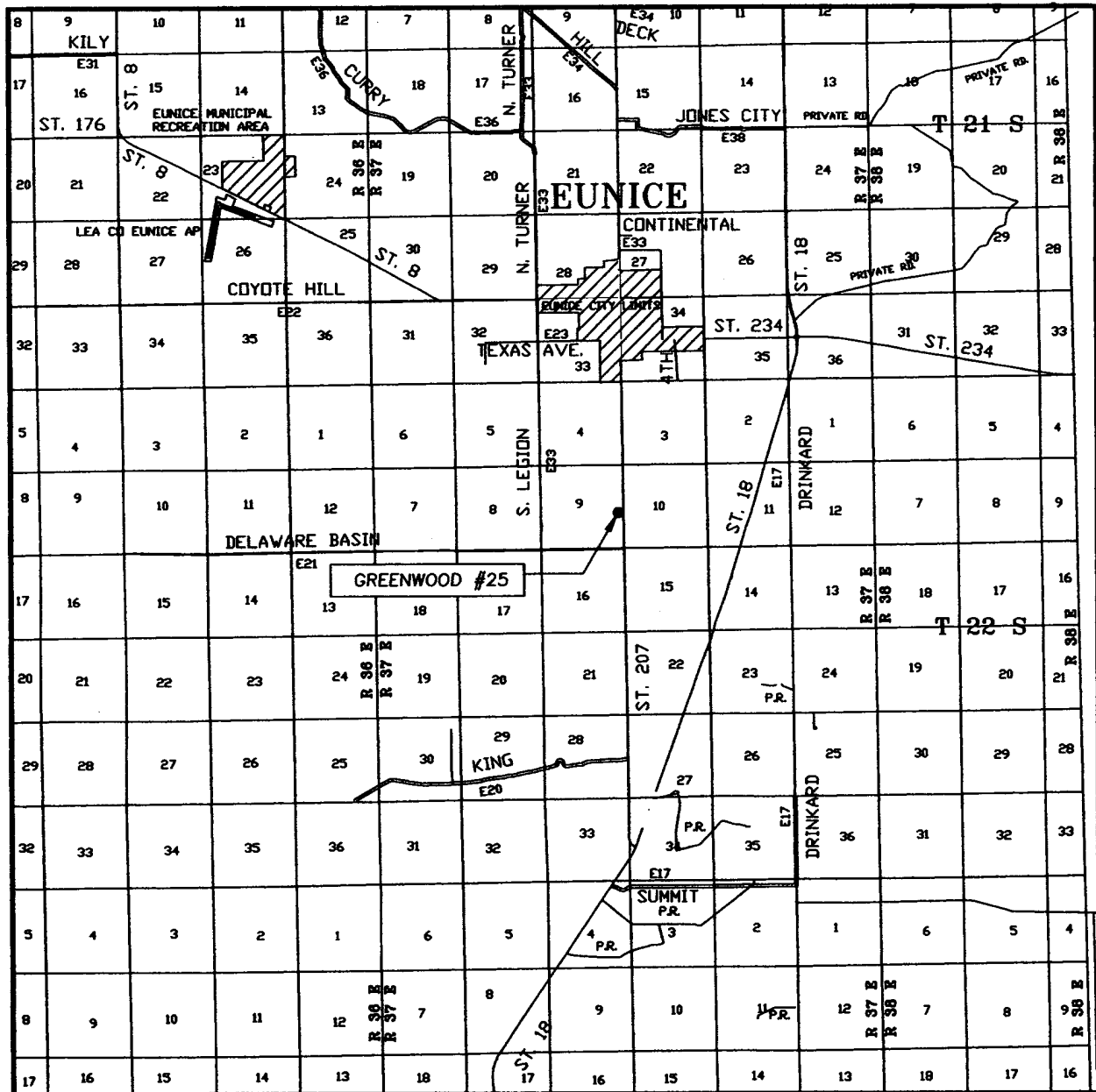
GREENWOOD #25 WELL

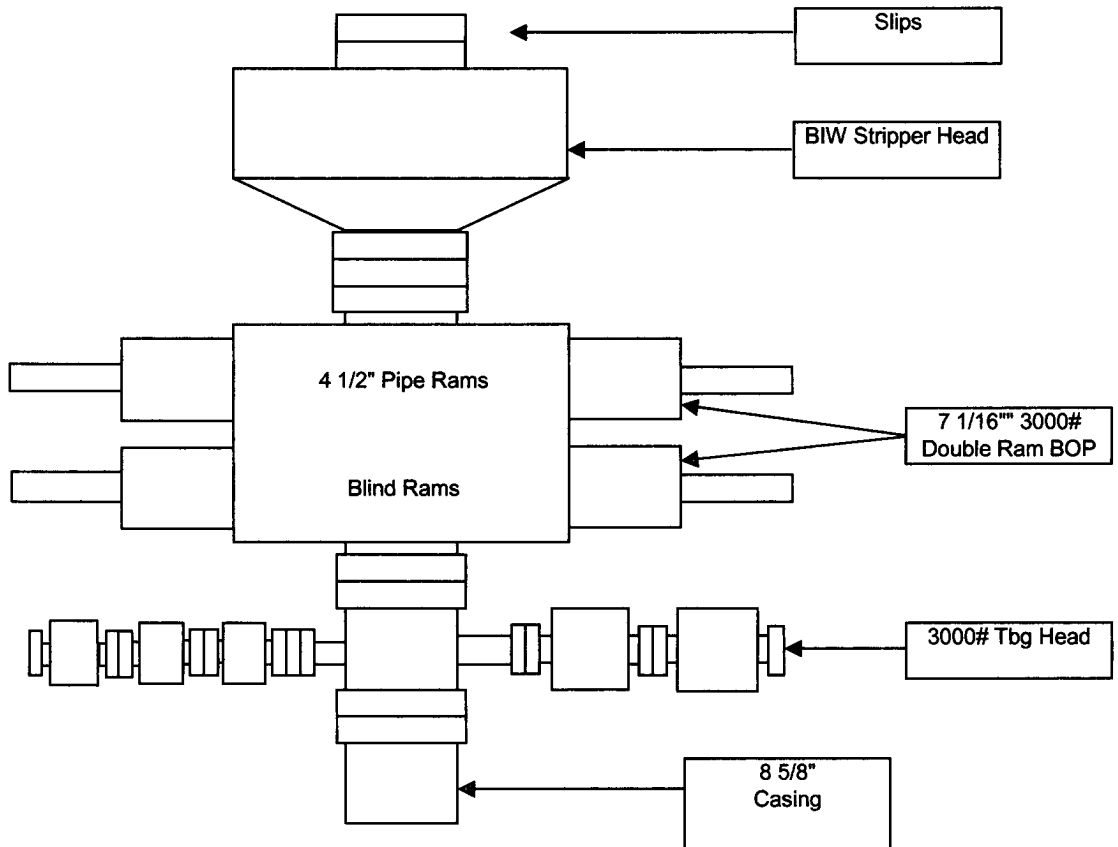
