1. Kill well.
2. POOH w/injection equipment.
3. Clean out to PBTD @4310'.
4. Plug back w/pea gravel to 4175'. Cap with 10' of cement. Tag new PBTD @4165'.
5. Set CICR and squeeze perms.
6. Test squeeze.
7. Acid treat well w/2000 gal of 15% NEFE HCL acid.
8. Perform scale squeeze.
9. Run back in hole with injection equipment.
10. Test casing and chart for the NMOCD.
11. Return well to injection.
