

Isolated csg leak f/2320'-2380'. Dumped 2 sx sand on RBP. RU BJ Svc, spot 30 sx Class 'C' cmt. TIH w/5 1/2" pkr to 2000', circ. clean. Sqz'd leaks fr/2320'-2380' w/1/4 bbl cmt into leaks. RD BJ Svc.
