Tailed in with 210 sx Premium Plus "C" (yld 1.33, wt 14.8). Circulated 280 sx to pit. Tested casing to 1500 psi, OK WOC 23 hrs, 25 min. Reduced hole to 8-3/4" and resumed drilling.
