Plan to plug and abandon was submitted 2008, prior to evaluation of unit and wells by current operator (assumed operations of Unit May 2008). Operator has received Incident of Noncompliance with corrective action (begin P&A operations) due by June 30. Contacted Hobbs Inspection office 06-30-2011, requesting extension of time for evaluation of well. Unit is being evaluated for remedial work and new drilling with respect to secondary recovery efforts. Therefore request an extension of time to October 31 2011 to evaluate and either return well to active status or plug and abandon.

Condition of Approval: By 10/31/11 the well is to either be on production or in the process of being abandoned.
