The release occurred when a valve was placed in the wrong position resulting in the overflow of the oil tank. The valve was placed in the correction position.

Describe Area Affected and Cleanup Action Taken.*

The release occurred within the lined facility. A vacuum truck was dispatched to remove all freestanding fluids. The containment was pressure washed to remove any residue from the release. The lined containment was inspected and found to be structurally sound.
