**BOP Break Testing Variance (Note: For 5M BOP or less)**

- While in transfer between wells, the BOPE shall be secured by the hydraulic carrier or cradle.
- Any well control event while drilling require notification to the BLM Petroleum Engineer prior to the commencement of any BOP Break Testing operations.
- A full BOP test is required prior to drilling the first deep intermediate hole section. If any subsequent hole interval is deeper than the first, a full BOP test will be required.

### **BATCH DRILLING SEQUENCE OF THE 40H and 41H:**

- SPUD Mesa 8105 #40H – rig up walked out, drill 17-1/2” hole and set 13-3/8” csg
- Walk to Mesa 8105 #41H, SPUD 17-1/2” hole and set 13-3/8” csg, test BOP, drill and set 9-5/8” csg, drill and set 5-1/2” csg
- Walk to Mesa B 8105 #40H, drill and set 9-5/8” csg, drill and set 5-1/2” csg
- Rig released

### **Variances:**

- BTA requests permission to allow BOP Break Testing under the following conditions:
  - After a full 5M BOP test is conducted before the first intermediate section is drilled on the pad.
