Run 40 bbls mud spacer, followed by 139 bbls MRF, 1347 sks 15.8 ppg tail cmt. Drop plug and displace with 433 bbls brine. 40 bbls mud spacer and 48 bbls MRD back to surface. Est TOC at 10022 ft.
