**Site Activity**

In November 2019, Expert Environmental personnel were onsite to start reclamation activities. All old piping, tanks and vessels were removed from location. The site was then ripped north to south and east to west. A berm was placed at the entrance of location to restrict vehicle access.

**Seed Plan**

The site will be seeded with LPC seed mixture. The site will be seeded at a broadcast rate. There will not be any primary or secondary noxious weeds within the seed mixture. Seeding will commence at the end of February or beginning of March 2020, when the site has the best chance of growth. The site will be monitored for any growth of noxious weeds for a period of 1 year if noxious weeds appear, they will be properly disposed of at an approved facility.
