This above unit and the wells to be shut in are capable of producing in paying quantities as evidenced by the most recent production reports. We seek to perpetuate unit leases due to the wells capability to produce in paying quantities and that this cessation of production is temporary.

Shut in to begin May 1, 2020. Production will resume when conditions improve and storage constraints ease. Thank you for your time spent reviewing this request.
