ConocoPhillips Company respectfully requests approval for additional surface disturbance on the subject lease. On 4/20/20, a leak was detected along a pipeline ROW approximately 1218' NW from the subject well - located at 32.8118, -103.7945 in Unit D Sec 29, T17S, R32E on lease NMLC029410A. The leak was approximately 4.25 bbls and in order to reach the contaminated location, a temporary access road is needed. The access road will be approximately 130' L x 10' W and constructed with a backhoe where the red line is depicted on the attached shapefile. The area of release will be hand dug. We will rake the tracks and seed the area once we are finished.
