8/10/11-----Tag existing 3 1/2" CIBP @ 3650'. Circ 40 bbls mlf. Spot 25 sxs cmt from 3650' (675'). Perf @ 2525' pkr @ 2135' Pressure tested to 1500psi OCD advised to spot 25 sx from 2575'. Spot 25 sxs cmt from 2582' woc & tag cmt plug @ 1936'.

8/11/11-----Perf 6 holes @ 1465'. Sqz 30 sxs cmt woc & tag cmt plug @ 1159'. Perf 6 jps @ 250' pump 50 sxs cmt from 250' Down 3 1/2" x 5 1/2" to surf. Shut in 5 1/2" & sqz 50 sx behind 5 1/2'.
