 09/24/20 Perf'd csg @ 2660. Set packer @ 1200 and pressured up on perms 600 psi. POH w/ packer. RIH w/ tbg and spotted 30 sx class C @ 2710-2256. WOC. Tag plug @ 2340. POH. ND BOP. Set packer @ 8' and sqz'd 125 sx in casing holes @ 916-885.
 09/25/20. Tagged cement @ 45'. Spotted 10 sx surface plug. RDMO.
 09/28/20 Moved in backhoe and welder. Dug out wellhead and anchors. Cut off wellhead. Welded on "Above Ground Dry Hole Marker". Removed wellhead and anchors, backfilled cellar. Cleaned location and moved off.
