Tap Rock plans on having these wells capable of production on 10/27/2020, however the gas pipeline from Lucid is estimated to be connected on 5/1/2021. Tap Rock requests permission to flare until a pipeline connection has been made available. Current projections estimate approximately 2000 MCF per well per day for the first 180 days of production until estimated connection date. If any significant changes in the timeline occur, a sundry to update all information will be submitted.
