10/16/2020: Drill 17.5 inch surface hole to 1055 ft.

10/16/2020: Run 13.375 inch J55 54.5 lb surface casing to 1043 ft. Pump 20 bbls gel spacer with plexifiber, 40 bbls gel with CTB-15, followed by 460 sks of 13.5 ppg lead cmt, 445 sks of 14.8 ppg tail cmt. Drop plug and displace with 155 bbls brine, 100 bbls of cmt returned back to surface. Test casing to 1500 PSI for 30 minutes, good test.

Surface Casing Details: Casing ran: 10/16/2020, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1043 ft, Cement 905 sacks, Yield 1.34, Class C, Pressure Held 1500 psi, Pres Drop 0.
