Pressured up on csg. to 500 psi. Lost 50 psi in 10 minutes. POH. Perf'd csg @ 3100'. RIH and set packer @ 2790'. Sqz'd 40 sx class C cement and displaced to 2900'. Pressured up to 2000 psi.

07/13/11 Tagged plug @ 2889'. POH. Perf'd csg @ 1600'. Set packer @ 1300'. Sqz'd 40 sx class C cement and displaced to 1490'. WOC. NO TAG. Re-Sqz'd 40 sx class C cement. Displace cement to 1490'. Pressured up to 900 psi. WOC.

07/14/11 Tagged plug @ 1460'. POH. ND BOP. Perf'd csg @ 462'. Sqz'd csg @ 462'. Sqz'd 125 sx class C cement to surface. Cleaned location and rigged down.

07/19/11 Moved in welder and backhoe. Dug out cellar, cut off wellhead. Welded on dry hole marker. Backfilled cellar. Cut off deadmen. Cleaned location and moved off.
