Legacy would also like to keep this well in TA'd status while it observes the results of the J M Denton #2 reactivation in the Wolfcamp zone. The #2 well was just recently reactivated and more time is needed to obtain results before making a decision on reactivating other wells in the Wolfcamp zone on Legacy's J M Denton lease.
