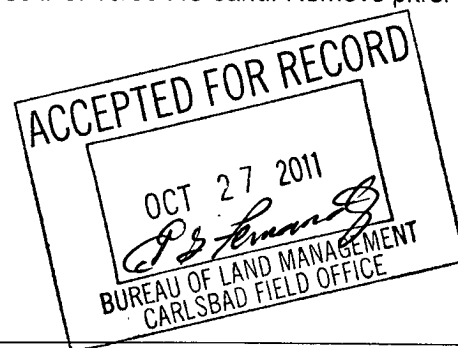

Perforate 5332-5337' (5 holes) and 5417-5422' (5 holes). Set stratal pkrs at 4989' and 5258'. Frac new perfs w/22,176 gals 20# XL gel and 35,980 # of 16/30 RC sand. Remove pkrs. RIH w/ 2-3/8" tbg and rods. RDMO. Place well back on production.
