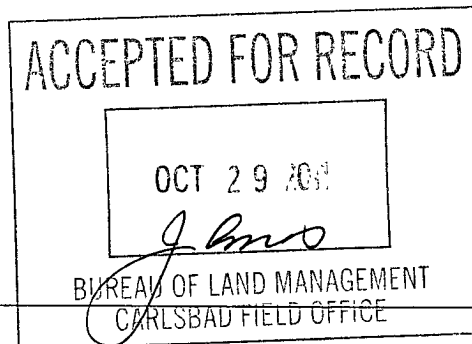

10/20/11 Ran 144 joints (5698') of 7" 26 lb/ft J-55 casing to 5695' with a DV tool at 3337'. Casing on bottom at 9 a.m 10/19/11. Wait on-BJ bulk cement for 2 hrs. BJ pump truck went down before pumping cement, waited 4 hrs to repair truck. Pumped 1st stage cement with 1000 gals Sealbond, 200 sx BJ lite w/ .4% sms, 5% salt and 200 sx Class C. Good lift pressure with good circulation. Opened DV tool and circulated 14 sx off DV tool. Circulated for 4 hours, cemented 2cd stage with 250 sx BJ lite and 200 sx Class C. Circulated 74 sx. Plug down at 10 p.m. WOC 24 hrs. BLM was notified but did not witness.
