The line will be 4" in diameter, fiber re-enforced polyethylene pipe with white out sheath, ANSI 150, with a normal operating pressure of 100 psi and a maximum allowable working pressure of 275 psi. This line will run from the Warren Unit battery #5 & #1 going west and ending at the McKee transfer facility. The line is generally depicted in the attached drawing.
