 4. Reason for commingling: Commingling the two wells would help to avoid pollution & unnecessary economic loss. The low production for the Bell Lake #21 (10-15 MCF/d) does not warrant setting a separate compressor. We would like to avoid flaring/venting for pollution reasons.

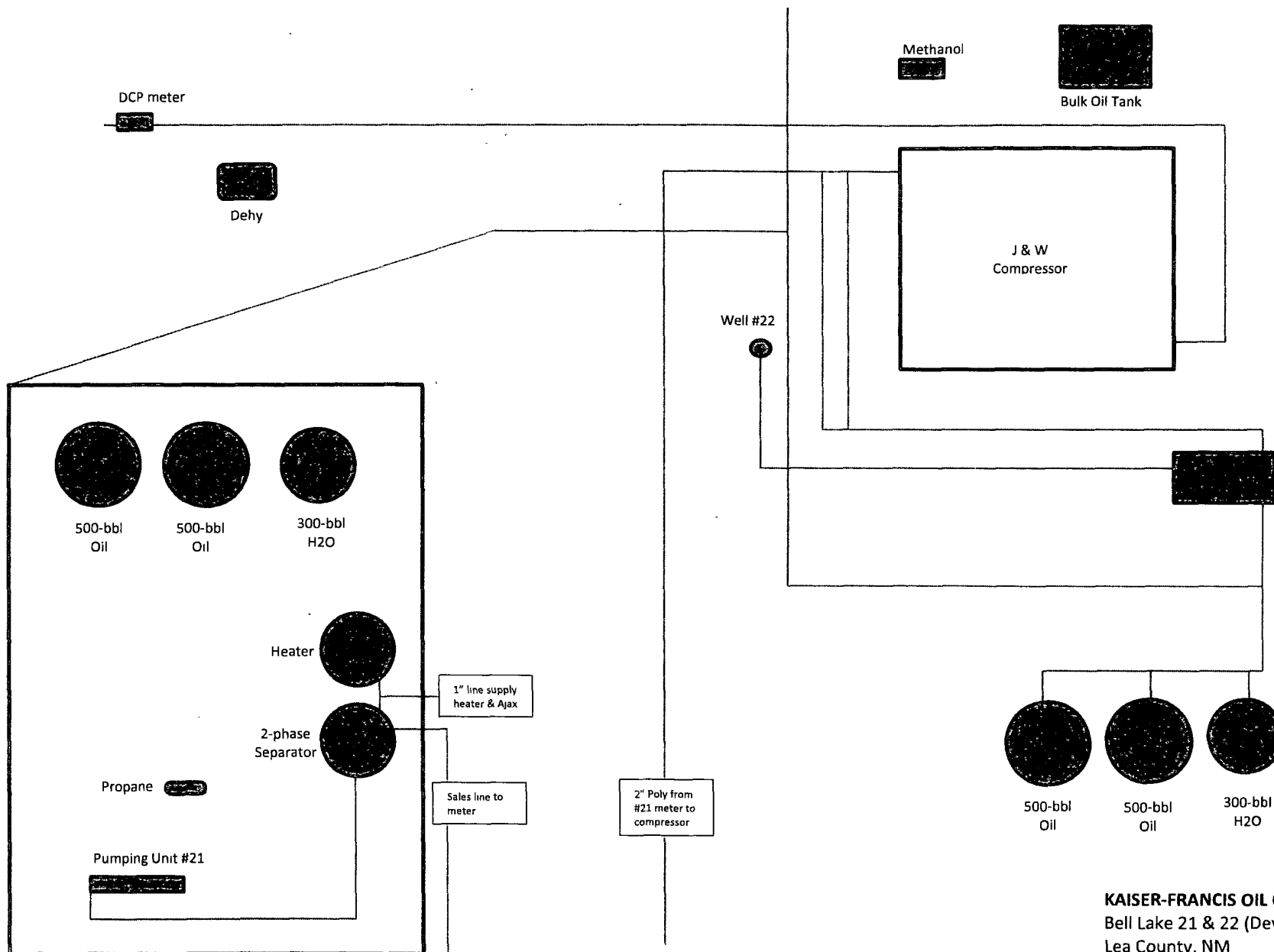
