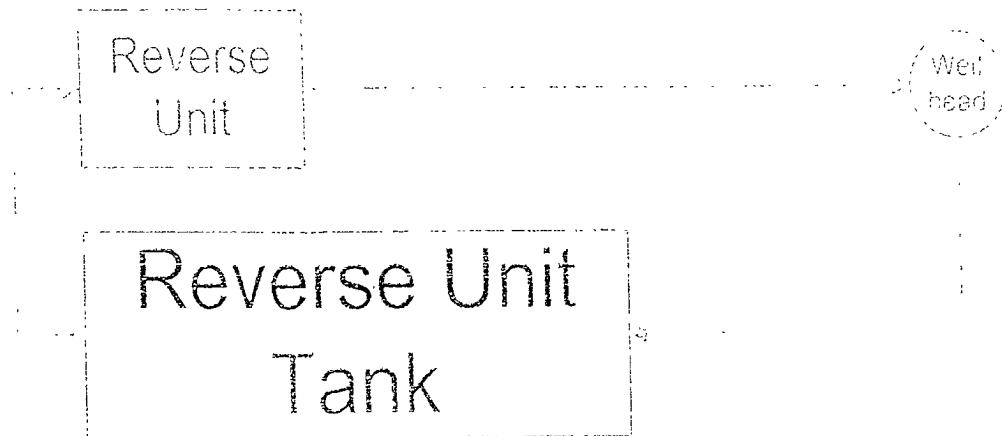

Operating and Maintenance Plan

1. All recovered fluids and solids will be discharged into reverse tank
2. Reverse tank will be continuously monitored by assigned rig crew so that tank will not be overfilled
3. Rig crew will "stump" trapped fluid" regularly at intervals indicated on rig plan
4. Documentation and visual inspection of reverse tank will be required on daily completion of operation

Closure Plan

1. All recovered fluids and solids will be removed from reverse tank and transferred to oil skid
2. All recovered fluids and solids will be discharged at a suitable off location - once this is done
