1. All recovered fluids and solids will be discharged into reverse tank
2. Reverse tank will be continuously monitored by designated operators so that tank level not be overfilled.
3. Storage will be used to keep fluid integrity of recovered materials.
4. Documentation and visual inspection of reverse tank will be completed before completion of each segment.
