This well was drilled to 95' x 18' hole. Water is standing in hole 90' below ground level. The well has 15' of 24" casing cemented in, with a locking lid. No other pipe or casing used in this well. We will cut the casing off at ground level and fill the entire wellbore with ready mix cement; install an appropriate above ground dry hole marker and recontour the surrounding area. No pits, tanks or bins were used while drilling this well.
