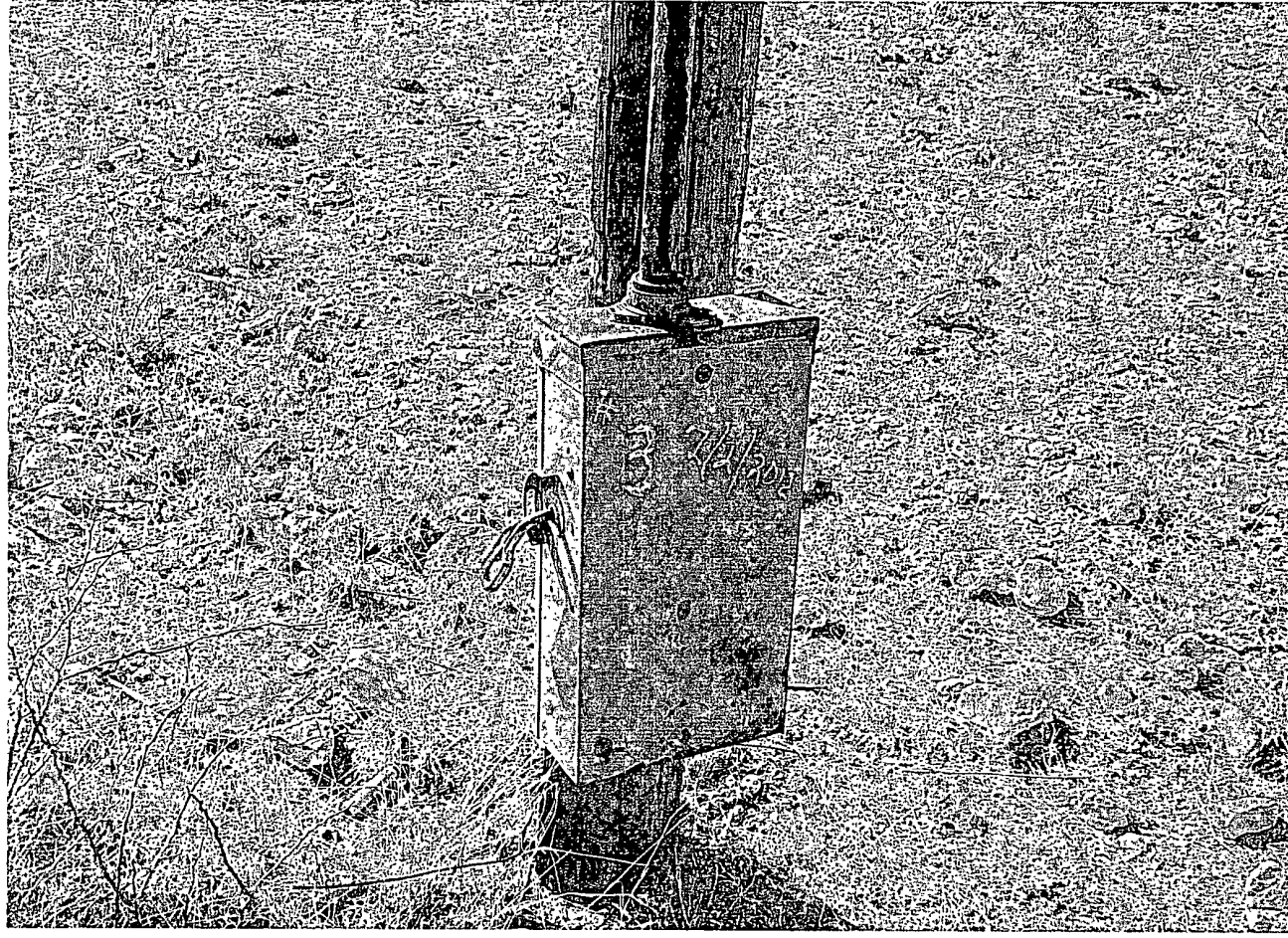


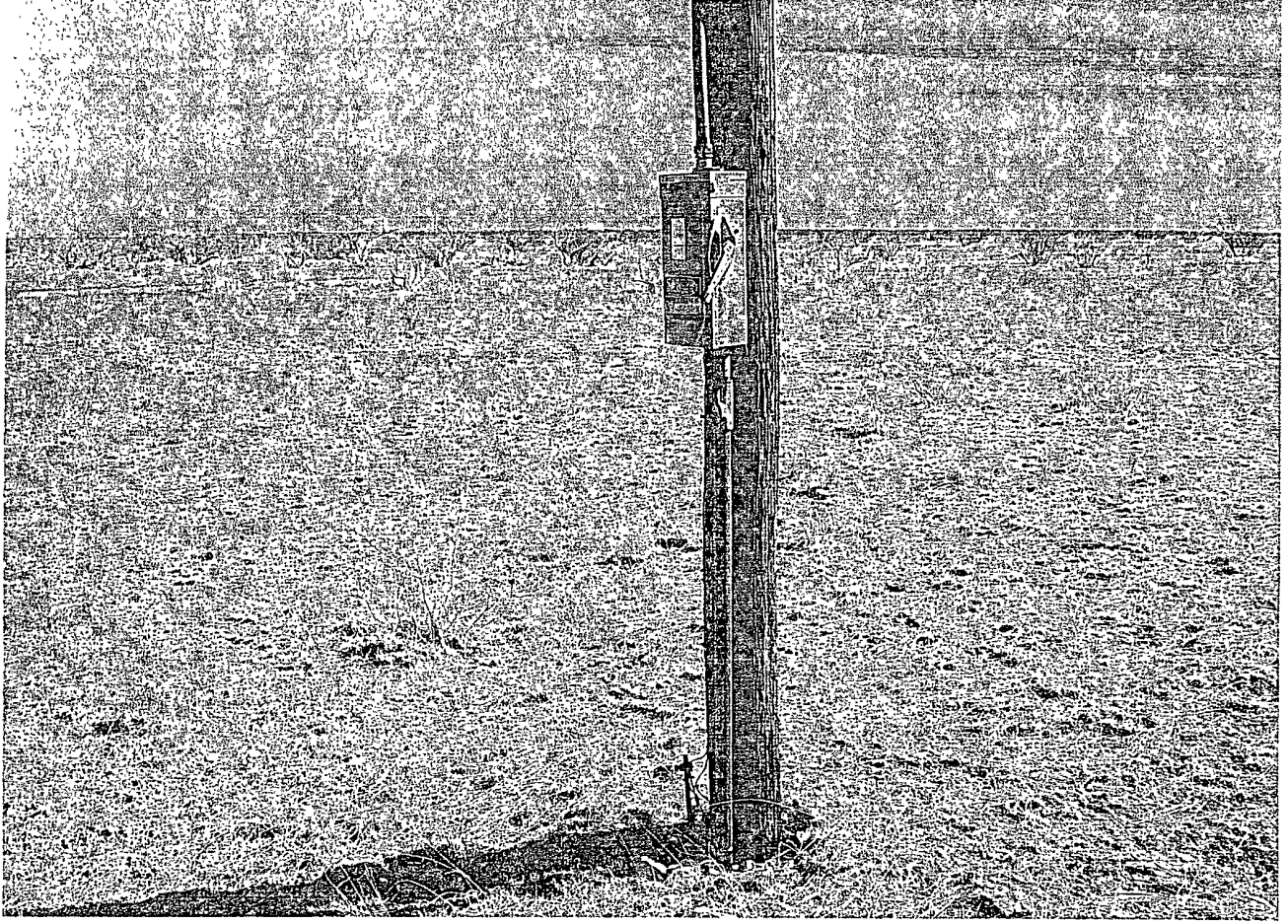
EAST EK QUEEN #2

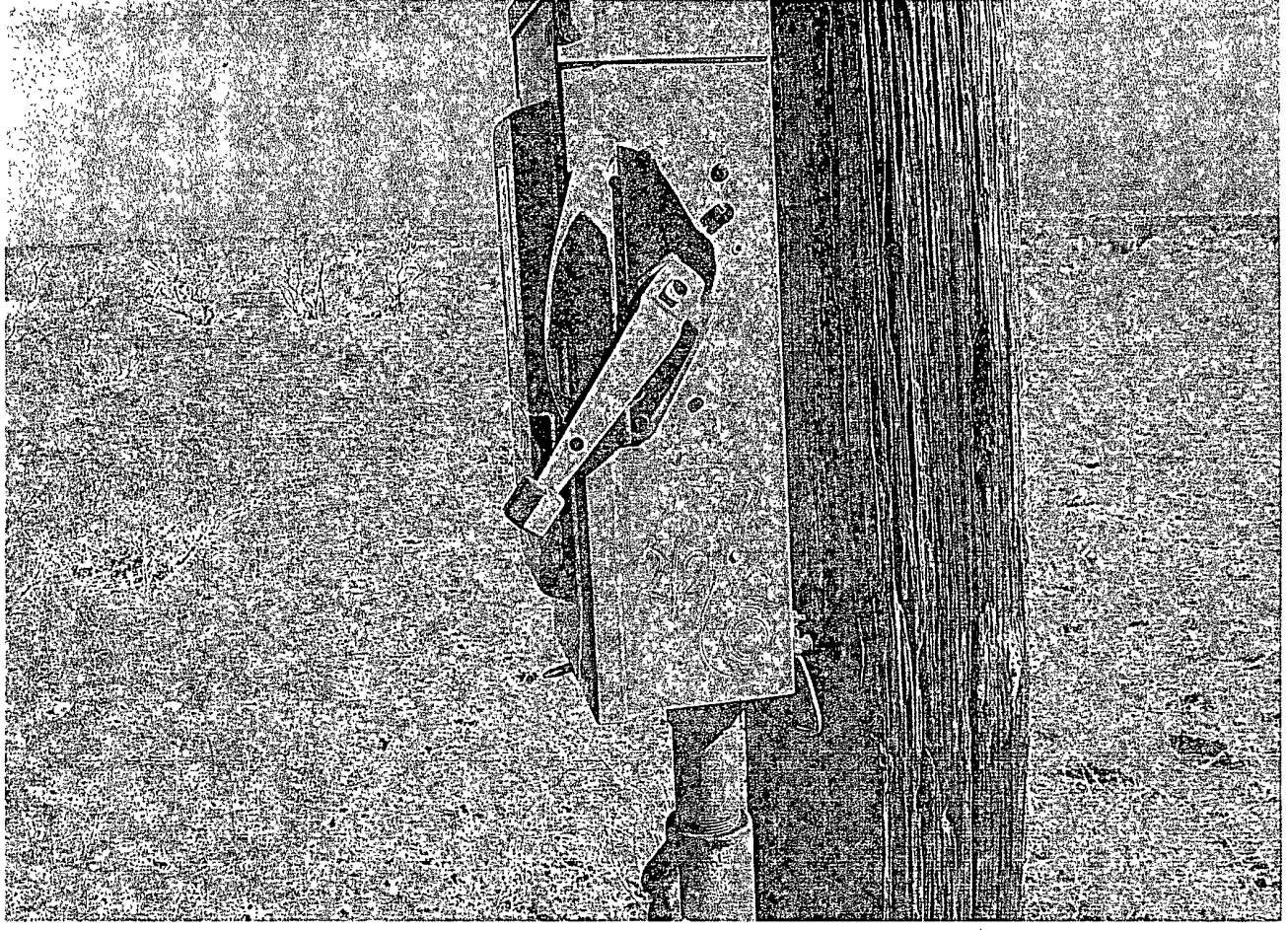


EAST EK QUEEN #3



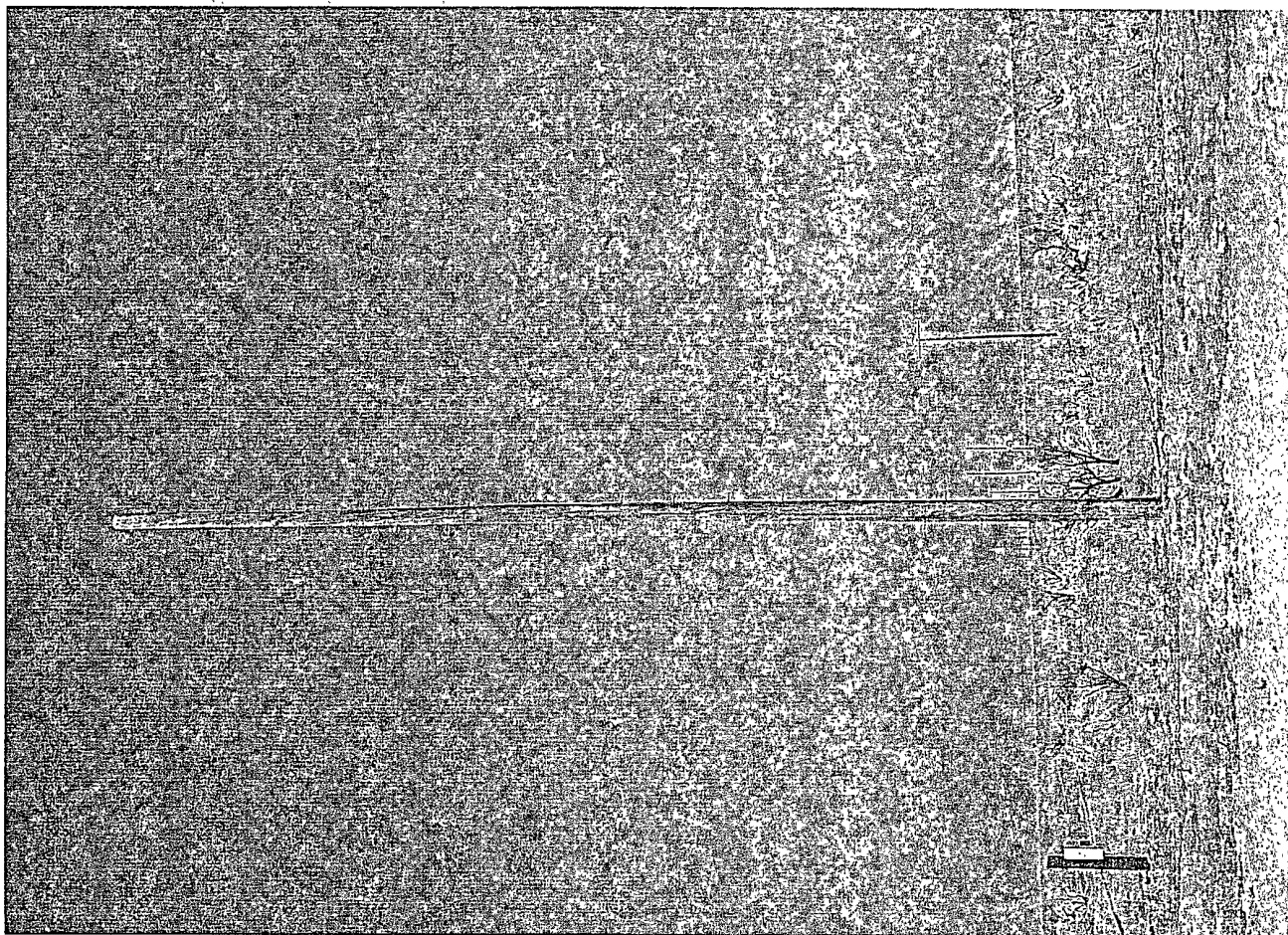


EAST EK QUEEN #7

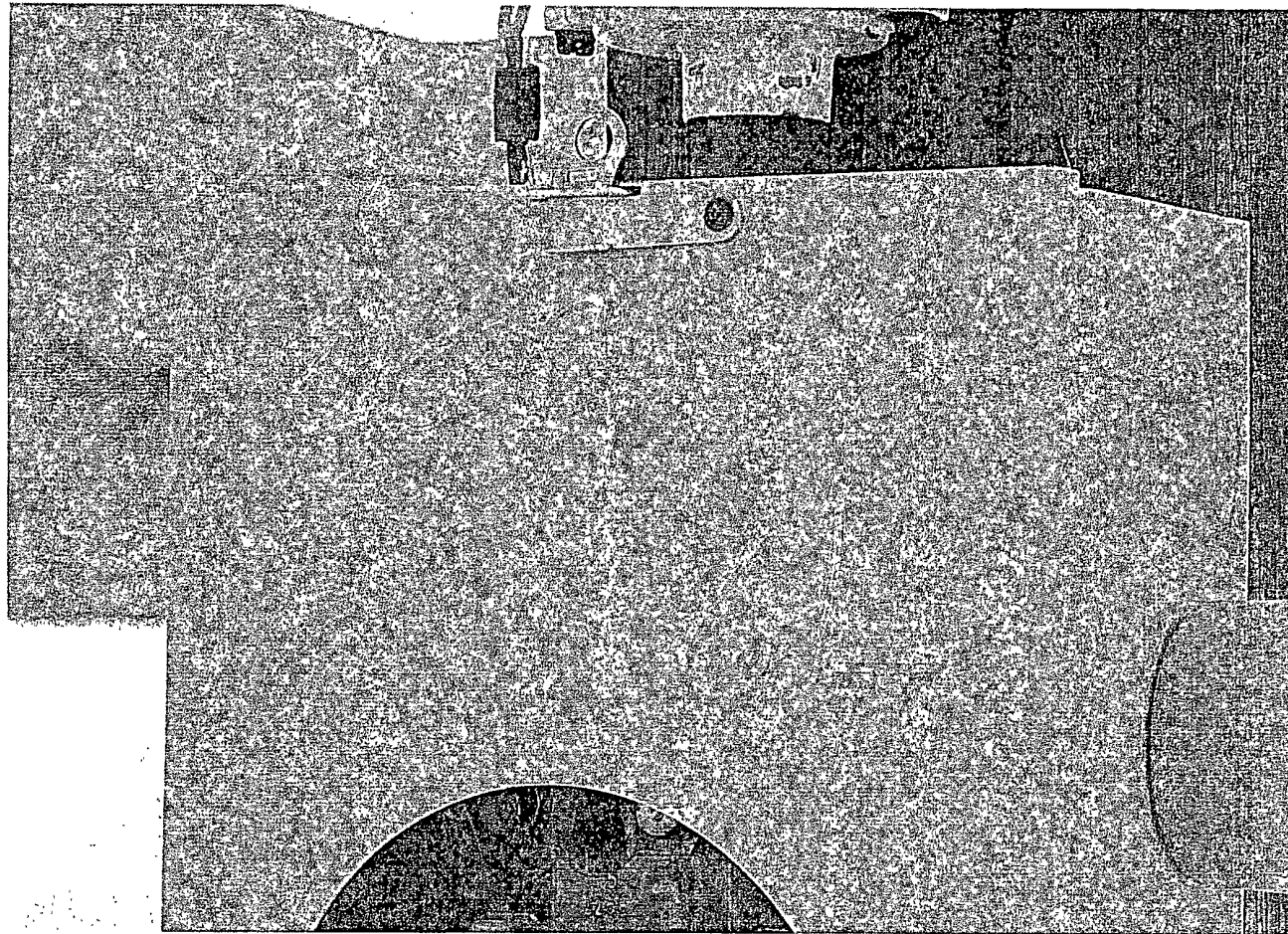

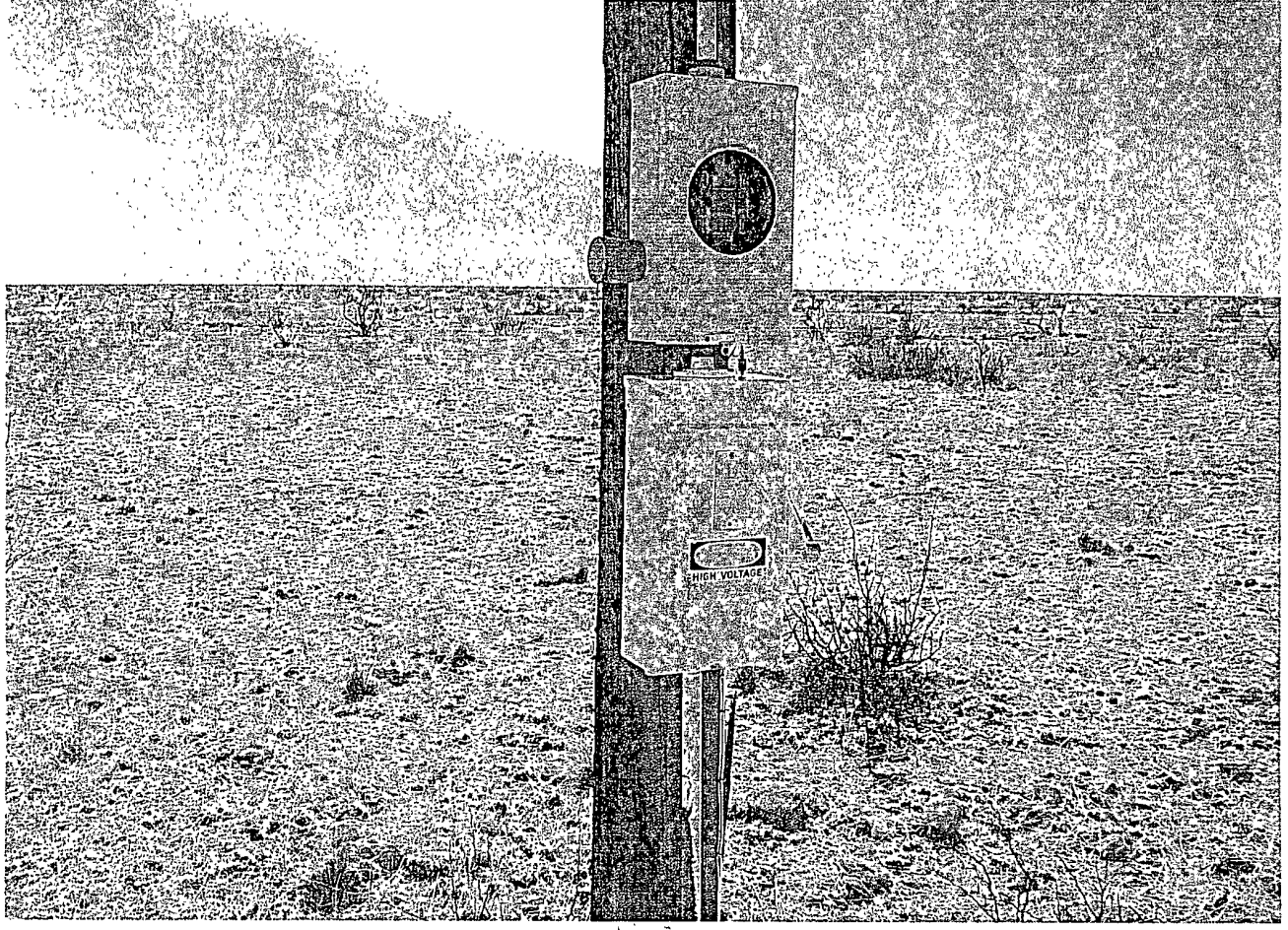

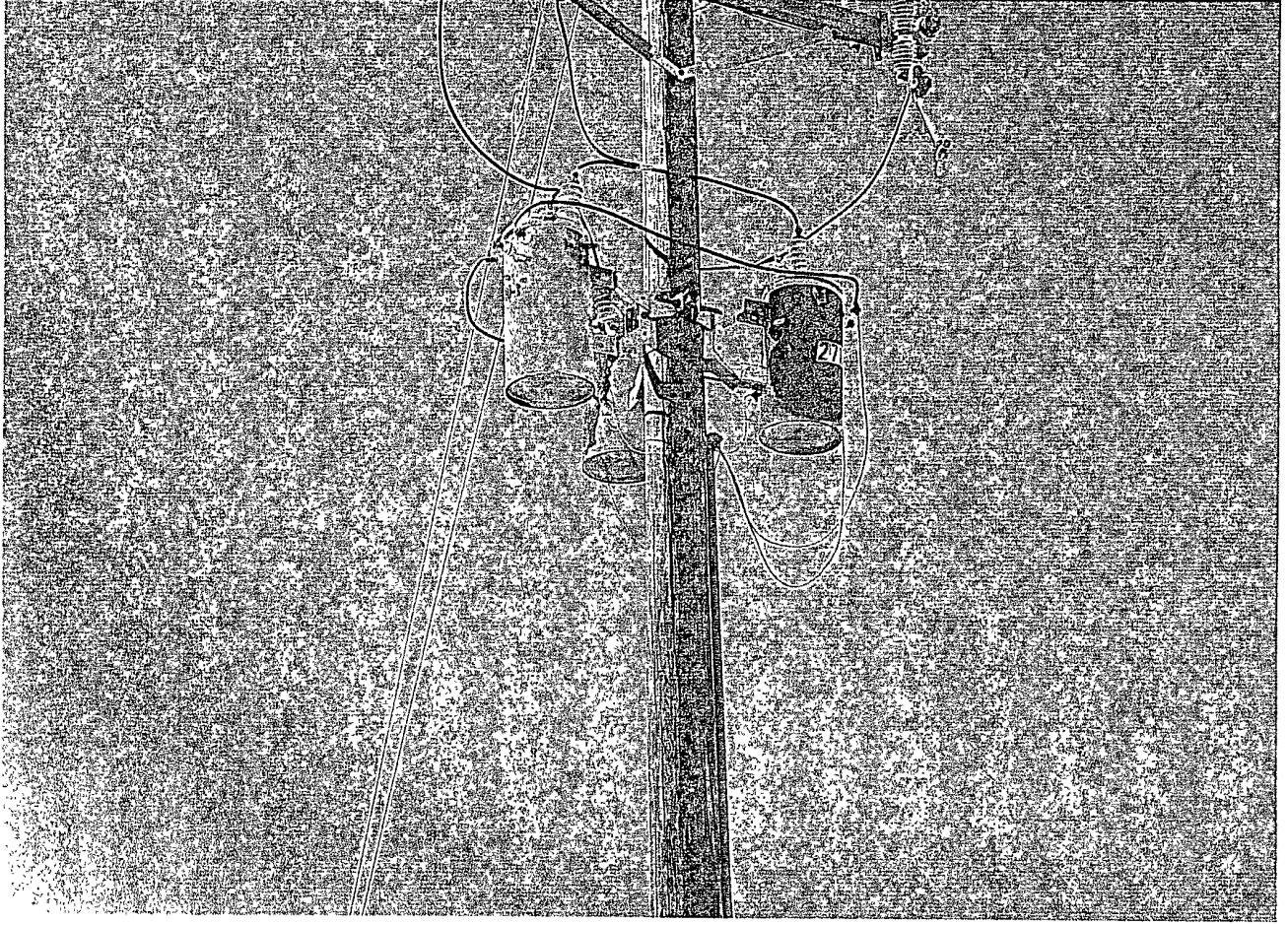
WEST OF WELL #2
