Tail: 200 sx 14.8 ppg Class C cement, 1.34 yield (100% excess)

Cement Stage 2:

Lead: 450 sx 12.9 ppg Class C cement, 1.88 yield (25% excess)

Tail: 100 sx 14.8 ppg Class C cement, 1.34 yield (25% excess)
