Well had leak from valve coming open on strainer. Clean up all contaminated soil and haul to Gandy Marly. Test soil to determine if additional clean-up is required. If tests fall into specs, replace dirt with new soil if off pad, caliche if on pad. Remove all handles from valves and bull plug all openings.
