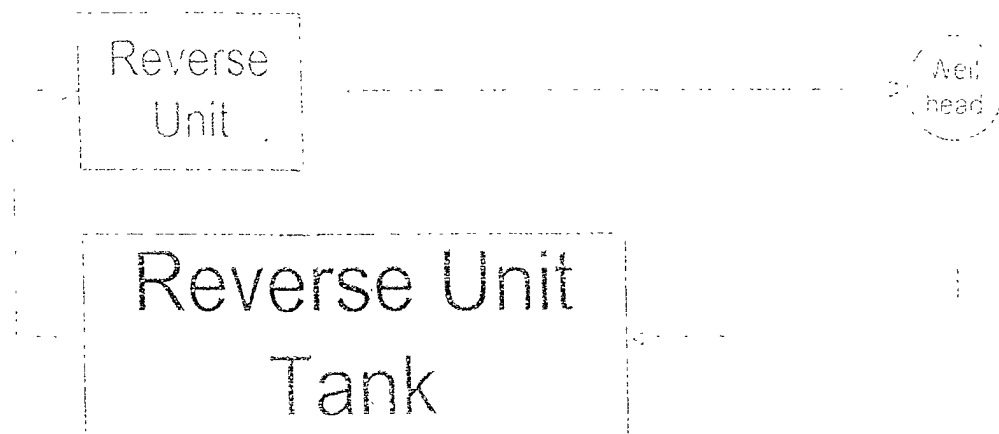

Operating and Maintenance Plan

1. All recovered liquids and solids will be discharged into reverse tank

2. Reverse tank will be continuously monitored by a high level alarm, so that tank will not be overfilled

3. High level will initiate procedure to stop oil from tank and stop pump

4. Operators should visually inspect oil level in tank and stop equipment if ready completion is being reached

Closure Plan

1. All recovered tanks and pipes will be completely reversed and well head shut in

2. All recovered tanks and pipes will be completely reversed and well head shut in and isolated
