A 4" x 2" swage, and 2" ball valve will be installed at the wellhead as sufficient capping of each shut-in well in the attached list. The wells are expected to be used as future utility wells in the Cato San Andres Unit; more specifically, as producers, injectors, or monitoring wells in the existing waterflood, or in an expansion of the existing waterflood. The necessary equipment was ordered in early January, but was found to be faulty when delivered. The equipment was returned to the supplier, and new equipment is expected to be delivered, and installed prior to the deadline of January 31, 2012.
