02/17/12 RIH open ended to 3645'. Circulated hole w/ mud laden fluid. Spotted 25 sx cement @ 3645-3400. POH to 2000'. WOC. Tagged plug @ 3336'. POH to 2533'. Pressure tested casing and held 600 psi. Spotted 25 sx cement @ 2533-2292. Pull out of cement WOC.  
02/20/12 Tagged plug @ 2240'. Perf'd csg @ 1336'. RIH and set packer @ 930'. Sqz'd 55 sx cement and displaced to 1130'. Pressured up to 850 psi, WOC. Tagged plug @ 1143'. POH. ND BOP. Perf'd csg. @ 413'. Sqz'd 120 sx cement and circulated to surface. Rigged down plugging equipment, cleaned location and moved off.  
02/22/12 Moved in welder and Backhoe. Dug out cellar. Cut off well head and welded on Ground Level Dry Hole Marker. Back filled cellar. Buried dead men. Cleaned location and moved off.
