**02/14/12 Tagged plug @ 3398'. POH w/ tbg. Set packer @ 34' and pressured up on casing to 600 psi. Held. Perf'd casing @ 2200'. Pressured up on csg to 1500 psi. RIH w/ tbg to 2250'. Spotted 25 sx cement @ 2250-2003. POH w/ tbg. WOC. Tagged plug @ 1984'. Perf'd csg @ 1300'. Set packer @ 900'. Sqz'd 40 sx cement. displaced to 1121'. Closed well in w/ 1200 psi. WOC.**

**02/15/12 Tagged plug @ 1075'. POH w/ tbg. ND BOP. Perf'd csg @ 60'. Sqz'd 20 sx cement to surface. Rigged down cleaned location and moved off.**

**02/16/12 Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on above ground Dry Hole Marker. Back filled cellar. Buried dead men. Cleaned location and moved off.**
