2-14-05: Acidized perfs from 3630-3653' w/4000 Gals NEFE. 2-15-05: Pull out of hole w/RBP.

2-16-05: RIH w/2 3/8" tubing.

3-11-05: Set pumpjack & hook up electricity.

3-14-05: Production Test : 8 bbls oil, 99 bbls water and 5 mcf gas per day.
