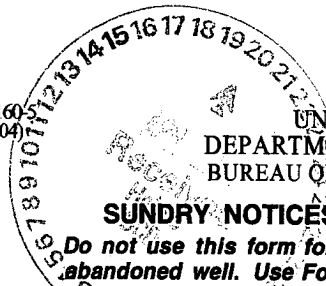

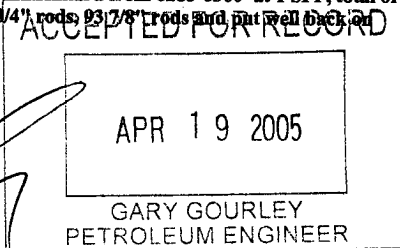

RIH w/ 207 jts 2-7/8" tbg, 164 3/4" rods, 93 7/8" rods and put well back on production in the Drinkard.
